### Ref: 2023/24:

- **73.** The Chairperson welcomed everyone and thanked them for attending the meeting, which was the second to take place in Ridge Village Hall.
- 74. Apologies for absence were received and accepted from Cllr Hedison and Cllr Myers.
- **75.** A declaration of interest pertaining to Agenda items. (5ii) was received from Cllr Becker and noted.
- **76.** The minutes of the last meeting were approved and signed by the Chairperson.

## **Planning & Planning Enforcement:**

- **77.** The following Planning Applications were discussed, and any public comments and representations received and here noted *in italics*:
  - i. Rafes Barn, Mimms Lane Ridge, Construction of a single-storey front extension, single-storey rear extension, and internal works to separate the rear of the garage to provide utility room, new window to existing ground floor bathroom and alterations to create access openings and replacement staircase. 23/1496/LBC
  - ii. Cedar House 73 Blanche Lane South Mimms Insertion of 2 x roof lights to approved side extension. 23/1499/LBC
- iii. Deeves Hall Barn Earls Lane South Mimms, To clad the building in black metal cladding. Certificate of Lawful Development 23/1494/CLP. A member of the public believed that this is a locally listed building, the Clerk undertook to verify and comment to Hertsmere as appropriate.
- iv. NIBSC Blanche Lane South Mimms, Erection of 9 x freestanding steel framed solar carports in the existing car park. 23/1376/FUL
- **78.** It was noted that the owners of the aggregates site next to Romani House have been served with a new enforcement notice by Hertsmere Borough Council.
- 79. It was noted that the new anti-flytipping signs have arrived and will start going up soon.
- **80.** It was noted that the timetable for the revised Hertsmere Local Plan should be ratified at the upcoming Hertsmere meeting.

#### **Finance:**

- **81.** There were no new items to approve.
- **82.** Resident Ken Riley kindly signed a letter for NatWest, again confirming the transfer of the dormant Ridge funds to the new combined Council.
