

Section 3 – External Auditor’s Report and Certificate 2023/24

South Mimms and Ridge Parish Council – HT0126

1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

Under a limited assurance review, the auditor is responsible for reviewing Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with NAO Auditor Guidance Note 02 (AGN 02) as issued by the NAO on behalf of the Comptroller and Auditor General. This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2024; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

2 External auditor’s limited assurance opinion 2023/24

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year’s AGAR.:

- Information received from the smaller authority indicates that fixed assets have not been included in Section 2, Box 9. As these assets were transferred from the discontinued South Mimms Parish Council, the smaller authority should agree a fixed asset valuation policy for these assets and ensure that they are included in Section 2, Box 9 in future.
- A bank balance of £9,560 transferred from South Mimms Parish Council has been treated as an opening balance and included in Section 2, Box 1. As the smaller authority was newly formed for 2023/24 this transfer should have been treated as income in Box 3. Section 2, Boxes 1 and 3 should read £0 and £10,040 respectively.

Other matters not affecting our opinion which we draw to the attention of the authority:

The smaller authority was newly formed this year; thus we have not reviewed any evidence to support the prior year comparatives on the AGAR.
